The undersigned agrees that our after-school program incorporates supervised and safe physical contact of a sporting nature. The undersigned recognizes and assumes all risks and does hereby release and forever discharge, waive and save harmless, protect and keep indemnified, After School Warriors and all their respective agents, employees and representatives from and against any and all kinds of actions, claims, costs, expenses and demands in respect to death, injury, loss and damage to my person, or property however caused and arising out of being permitted to attend all in any way prior to, during or subsequent to programs and/or activities as a member. Parents also acknowledge that this physical activity is offered in compliance with Fraser Health Physical Play guidelines. Photos may be taken of the children while in the daycare for promotional purposes, such as for use on our Facebook wall or website. Please inform us if you wish your child not to be photographed, and we will do our best to avoid having your child in any photos. You must also consent to ASW sharing information regarding your child and enrollment with the Provincial Government.

Tuition Agreement:

Upon signature of this agreement, the applicant agrees that membership tuition includes a twelve-month ongoing program, and therefore agrees to make tuition payments in the form of monthly E-Transfers or 12 postdated cheques. E-transfer sent on the 1st of each month is preferred. Applicable fees of \$35.00 will be charged for returned cheques. Late fees of \$50 will be applied if payment is not received by the third week of the month of payment, unless arrangements have been previously made with ASW. After School Warriors is not responsible for refunding vacation time or missed classes. A thirty-day written notice is required upon suspension or termination of membership. After School Warriors reserves the right to terminate membership due to declining school enrolment numbers. All contracts are deemed fulfilled at the end of the summer daycare portoin, and a new contract must be signed prior to the new school year starting. After School Warriors may make changes to the program and rates as deemed necessary. Written notice of changes will be provided and will be discussed. Summer programs are mandatory and are provided at a cost of \$650 per month. Upon signing this contract, ASW enters an agreement with the undersigned, and not any other parent or guardian.

Fee Breakdown:

This membership consists of a ten-month commitment at a total cost of \$485 per child. Before School care may be provided for an additional \$150 a month, equaling a total monthly cost of \$635. Summer Care is provided at a fee of \$650 per month for members, and \$750 per month for non-members. These fees are due at the beginning of each month. ASW retains the right to apply an additional fee to the monthly fee for professional development day (Pro-D Day) or snow day coverage at their sole discretion. If the fee is applied, it will be \$20 for the day. The After School Program rate includes provincial wide professional development daycare (drop off at 8:30 am, pick up no later than 6:30 pm). This does not include winter/spring/summer break daycare. Spring break care may be provided at an additional rate of \$20 per day. Winter break is not covered under our program. There is no reduction in fee for the month of December due to the winter break. There is also no extra fee for months with a 5th week in them. A void cheque is required upon registration in order for ASW to pursue unpaid daycare fees. Monthly fees include: pick up from school, transportation to the centre, homework help, free activity time, and Taekwondo classes.

Part Time:

After school warriors provides part time care as long as there is space available. This arrangement can change upon demand of the program and will be given 30 days written notice of any changes. Part time care consists of anywhere from 1-2 days. Anything more than 2 days is considered full time. Pro-D Days are not covered under part time care, and require a top-up of \$20 per day. If the Pro-D Day is not on a regularly schedules part time day, the \$45 fee will apply.

Accountability/Assessment:

Children in our care will be held accountable for their actions within the daycare. Disrespectful behavior will not be tolerated. Parents will be informed of any negative behavior. If a child damages or destroys any equipment owned by the daycare, the item will be replaced and the cost will be added to the next month’s invoice. Failure to pay for damaged or destroyed items will result in a cancellation of childcare services. Violent behavior will not be tolerated and may result in immediate expulsion from daycare, and a refund will not be provided.

In order to tailor our programming to each child in our care, ASW may intermittently collaborate with community-based programs that provide soft-assessment services such as Ridge Meadows Association for Community Living. ASW requires your permission to allow organizations like RMACL to potentially observe your child and suggest behaviour based solutions. These solutions will be discussed with parents. Vehicle Policy:

After School Warriors provides vehicular transport for most of the students in the program. After School Warriors will only transport children in safe vehicles. Drivers of any vehicles employed by the program will hold valid Driver’s Licenses and After School Warriors will have driver’s abstracts on hand. Abstracts will also be routinely updated. Drivers with unsafe driving practices will not be permitted to drive children. After School Warriors will not be held liable for any injury or death due to a vehicular collision. All After School Warriors drivers will adhere to driving laws and regulations. (Initials) _____

Peanuts/ Tree Nut Policy:

ASW is a nut free daycare. Do not send any food that contains peanuts or tree nuts. Examples: Peanut butter, Nutella, nougat, trail mix. If nuts must be consumed due to diet (vegan etc) please inform ASW when you send nuts so we can separate children with nut allergies. (Initials) _____

Late Fees / Failure to notify:

After School Warriors strives to pick up enrolled children as quickly as possible to reduce the amount of time children have to wait for the vans to arrive. ASW requires parents to notify ASW as soon as possible if their child/children will not be requiring pick up. Failure to notify ASW before 2pm **will** result in a fine of \$20 per instance, which will be added to the next month’s fee. ASW prides itself for offering licensed daycare until 6:30pm. However, ASW would like to ensure parents realize that ASW has to pay extra wages to its employees when parents are late for pickups. Parents who fail to pick up their children before 6:30pm will have a \$20 late charge per half hour added to their fees per instance. (Initials) _____

Screen Time:

During the school year, screen time is only permitted on “Fun Fridays’ if the children have earned it. During spring break and summer programming, due to the much longer days, approximately 1 hour of screen time is permitted. Children are permitted to bring their own electronics. Apps such as TikTok, Youtube, Fortnite, and any apps with access to general media/social media are not allowed. We provide age-appropriate games such as MineCraft and MarioKart etc. We also occasionally show movies from Disney+. Please inform us if electronics are an issue. (Initials) _____
